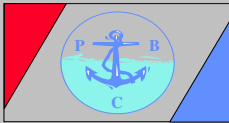

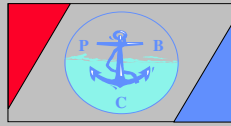

**VI. CONDITIONS OF MEMBERSHIP**

1. 2 passport-sized photographs of both the applicant and spouse must accompany all applications.
2. All accounts will be settled on a monthly basis (Reference Article 21 of the Piasau Boat Club Constitution).
3. All cheques are to be made payable to the **Piasau Boat Club**.
4. All information provided by the applicants will be kept confidential.
5. Proposer and Seconder must be Full or Associate Members of the Club.
6. The PBC Committee reserves the right to request a refundable deposit from Full Member (amount of deposit to be decided by the PBC committee) in the event that the Member has a record of slow payment in settling Club accounts.
7. A fixed deposit fee of RM1000.00 shall be payable by Associate, Country Associate & Senior Citizen members at the time their application to join the Club.
8. Members on Temporary transfer to out of town can apply to convert their membership to Country for the duration they are out of the area. They will be reinstated to their original membership status upon return to the area. Working on shifts (offshore/onshore does not make one eligible for Country Membership).
9. For **Senior Citizen** application, a proof of age must be provided to Piasau Boat Club, such as an original Identity Card or Passport, which will be photo copied and kept at the PBC's office.
10. Applicant also request to fill-in /signed the '**Piasau Boat Club Sports Waiver Form**' and returned to Club office together with Membership Form.
11. The minimum duration of membership is 6 months.
12. **Notice of Resignation** –Members must provide one month formal notice to **Secretary** of the Club.
